
Project Overview

The South Molton Triangle consists of:

'North and South' buildings - Two office buildings above ground floor retail/restaurants/Running Horse Pub

South Molton Street - 33 homes (22 private & 11 affordable) above ground and lower ground floor retail/F&B

Hotel – 31 bedrooms at 40-46 Brook Street



North and South Buildings

Project Update - North & South - McGee.

Works to Date:

- Hoarding erection is complete, now installed on Brook Street and Davies Street.
- Scaffold to site perimeter mostly complete.
- Demolition of low-rise buildings to the South Side of Davies Mews complete.
- Façade retention structure on Brook Street erected.
- Underpinning works to Brook Street and Davies Mews.
- PAYE have been cleaning the façade stones prior to deconstruction works on Brookfield House.
- Weather protection and repairs to 46 Brook Street Party Wall.
- Roof of 48-58 Brook Street removed.
- Demolition of 56 Davies Street.
- UKPN substation connection works.
- Installation of temporary cabins to the rear of 56 Davies Street.
- Commencement of pilling works.








Demolition Works.

- Demolition works commenced in November 2023.
- Demolition of the low-rise buildings to the South Side of Davies Mews complete.
- Brookfield House, 56 Davies Street and 48 Brook Street demolition is well underway.
- The demolition work is mostly being carried out by an excavator with a muncher attachment, to reduce the noise and vibration generated from the works.
- The bulk of the demolition works will be completed in the next two months.


Piling & Basement Works.

Pilling works commenced in February 2024.

This has started with the installation of new secant piles to form the second level of basement.

An auger cleaner is attached to the piling rig to reduce noise and vibration.





Environment and Sustainability.

We are targeting a BREEAM Outstanding sustainability rating for the project.

Through careful planning, selective procurement and segregation of waste streams we are currently on track to achieve this goal through recycling and reuse.

The project has ambitious carbon reduction targets, which McGee are striving to aid in achieving by making carbon savings wherever possible during our works. This includes:

- lower carbon concrete mixes
- electric plant & machinery
- re-used steelwork
- diverting 99% of our waste from landfill

Brick and Stonework salvaging

The stonework from the façade of 56 Davies Street and Brookfield House is being sensitively salvaged and will be used in reconstruction.

PAYE oversee the salvaging of this stonework; bricks are removed, cleaned, palletised and sent to an offsite storage facility.





Corporate Social Responsibility.

- McGee has spent a collective 36 Hours volunteering with local charities and initiatives.
- In 2023 alone we spent c.**£340,000** in the local supply chains.
- So far 15 apprentices and graduates have had a cumulative 228 weeks working on site.
- 3 work experience students have also had placements on site.

Project Update – South Molton Street

- At the last CLG, we advised that RED Construction were the contractors for South Molton Street.
- Unexpected existing conditions in the building have meant we need to make minor updates to the refurbishment design and approach; this requires an updated Listed Building Consent which has delayed the start of work on SMS.
- We have also been unable to reach a commercial agreement with RED Construction and have stood them down from the project.
- We're engaging with other contractors in relation to the works on SMS and hope to appoint a new contractor in late spring. Until then, Grosvenor is managing the site including site security. Internal demolition and excavations will continue in the meantime.
- We will keep you updated through existing channels including this CLG and newsletters.






